

# Terms and conditions - Refer a friend

#### In these Offer Terms:

"Bonus" means the amount payable to you if you meet these Offer Terms;

**"Friend**" means an individual or company who is referred by you and who meets the Deposit and Trade Requirements under these Offer Terms;

"Offer" means this Refer a Friend Offer, which is offered to you under these Offer Terms;

**"We" "us"** or **"our"** means Pepperstone Group Limited, ACN 147 055 703, AFSL 414530, of Level 16, Tower One, 727 Collins Street, Melbourne, VIC 3008, Australia.; and

**"You" "your"** or **"yours"** means you, if you meet the criteria of an Eligible Client under these Offer Terms.

#### 1. The Bonus

For you to receive your Bonus:

- 1.1 You must comply with these Offer Terms; and
- 1.2 Your Friend must:
  - (a) Step 1: Open a Standard or Razor account with Pepperstone, and provide your email address where indicated in their account application; and
  - (b) Step 2: Meet the deposit and trade requirements below:

  - (b) minor currency pairs (AUDCAD, AUDCHF, AUDNZD, AUDSGD, EURAUD, EURCHF, EURGBP, GBPAUD, GBPCHF, NZDUSD); and



- (c) crosses (CADCHF, EURCAD, EURNZD, GBPCAD, GBPNZD, USDCAD, AUDJPY, CADJPY, CHFJPY, EURJPY, GBPJPY, NZDJPY).
